SEWERS

- G-1. Approving the proposed action of Bloomfield Municipal Authority to acquire all facilities constituting the sewer system owned and operated by this Borough; approving the terms and conditions of a proposed agreement between this Borough and said Authority whereby, inter alia, this Borough will agree to grant, convey, assign and transfer to said Authority all of its rights, title and interest in and to all of said facilities constituting said sewer system, together with all appurtenant facilities and properties, including all property, real, personal and mixed, used or useful in connection therewith, in the express condition that said Authority will make certain alterations and improvements and will construct certain additions to said sewer system and will lease said sewer system, including all alterations, improvements and additions thereto, to this Borough for operation and use; authorizing and directing proper officers of this Borough to execute and deliver the aforesaid proposed agreement, and authorizing and directing proper officers of this Borough to take all action necessary of desirable in connection with consummation of the terms and conditions of the aforesaid proposed agreement.

Black Jr., Inc., which contract involves the electrical construction required in connection with the construction of additions, alterations and improvements to said sewage treatment plant of this Borough; assigning to said Bloomfield Municipal Authority all right, title and interest of this Borough in and to a certain grant, in the maximum amount of \$24,630, made to this Borough by the Public Health Service, Department of Health, Education and Welfare, United States of America, to aid in the cost of construction of additions, alterations and improvements to said sewage treatment plant of this Borough; authorizing execution and delivery of appropriate instruments of assignment; and authorizing other necessary action.

WATER

Approving the proposed action of the Bloomfield Borough Water Authority in purchasing all the stock of the Bloomfield Water and Sewer Company and the acquisition of the property, assets, and franchises of the Company through its liquidation and dissolution; and approving the purchase agreement, whereby the Authority will acquire said stock; and providing for the issuance of water revenue bonds to provide funds to finance the acquisition of the stock of the Company to pay the Company's liabilities, and to provide funds for working capital, improvements and costs of acquisition. (Resolution, 6/7/1952)(The bonds referred to were issued by the Authority, not the Borough)
